

**State Level Advisory Committee**  
**Constituted under Bio Medical Waste Management Rules, 2016**  
**Government of Haryana**

**ORDER**

Whereas, the revised guidelines for Common Bio Medical Waste Management Treatment and Disposal Facilities (CBWTFs) issued by Central Pollution Control Board (CPCB) on 21.12.2016, provides for revision of rates to be charged from Health Care Facilities (HCFs) by the CBWTFs has to be done by the State Level Advisory Committee (SLAC) constituted under the Bio Medical Waste Management Rules, 2016 in consultation with the CPCB, Medical Association and representatives of CBWTF;

Whereas, the rates to be charged by CBWTFs in Haryana were fixed by Government vide order dated 28.05.2019;

Whereas, the representations submitted by CBWTFs, IMA and Private/Medical Laboratory Technician Welfare Association regarding revision of rates fixed by Government vide order dated 28.05.2019 were taken up by SLAC in its 7th meeting held on 18.02.2022 and accordingly a Sub-Committee under the Chairmanship of Mission Director, National Health Mission, Haryana with DG, Animal Husbandry and Dairy Department, Director, Health Services, Government of Haryana and Sr. Environmental Engineer (SWM Cell), HSPCB was constituted by SLAC vide its order dated 10.03.2022 to examine the representations of CBWTFs, IMT & Private / Medical Laboratory Technician Welfare Association;

Whereas, the above stated Sub- Committee after examining the representations of CBWTFs, IMA & Private/Medical Laboratory Technician Welfare Association submitted their recommendation regarding revision of rates to be charged by CBWTFs in Haryana to Chairman SLAC for considerations; and,

Whereas, SLAC in its 8th meeting held on 10.05.2022, upon considering the recommendations of the Sub Committee and after careful consideration of all the points raised by representative of CBWTFs, IMA and Private/Medical Laboratory Technician Welfare Association decided that the rates already fixed by the Govt. vide its order dated 28.05.2019 should be increased by 10% w.e.f 01.04.2022;

Therefore, it is ordered that the following rates shall come into force with effect from 1st April, 2022 and the said rates will be applicable for the current financial year i.e 2022-2023, to be charged by the CBWTFs in Haryana from different categories of both Govt. and private HCFs/Health Establishments,

Category	Rates proposed (including disposal bags)
HCFs without Beds to 5 beds	Rs. 1100/month
HCFs with 6-10 Beds + stand alone Labs and diagnostic centers	Rs. 2035/month
Facilities with 11-20 Beds	Rs. 2475/month
Facilities with 21-30 Beds	Rs. 4840/month
Facilities with 31-50 Beds	Rs. 6050/month
All Facilities with more than 50 Beds	Rs. 8.8 per bed per day
Veterinary Hospitals	Rs. 1210/per month

It is further, directed that an additional fixed amount of Rs. 5500/- per facilities per month in case of PHC/CHC, which are established outside the municipal limits of District Headquarters, where the CBWTFs concerned is established, and that an additional amount of Rs. 33/- per kg shall be charged by the CBWTF from the HCFs with capacity of more than 50 beds, if the HCF generates bio medical waste more than 325 gms per day per bed.


